

## **Rules for 2018 Lions Clubs International** **New Member Sponsorship Sweepstakes**

### **1. Eligibility**

Only Lions members who have sponsored a new member between April 1 and June 15, 2018 are eligible to enter this sweepstakes. No purchase necessary. Entrants must be 18 years or older at time of entry in order to participate. All federal, state, and local laws and regulations apply. Entries may be earned for each new Lions member sponsored during the sweepstakes period. The sweepstakes begins at 12:00 a.m. CST on April 1, 2018 and ends at 11:59 p.m. CST on June 15, 2018. ### **2. Exclusions**

The International Board of Directors and their families, Past International Presidents and their families, Past International Directors and their spouses, employees of Lions Clubs International and Lions Clubs International Foundation, and their families are excluded. Void where prohibited or restricted by law.

### **3. Entry Instructions**

Once new Lions member sponsorship is confirmed, participant will automatically be entered to win. One entry will be awarded per confirmed sponsorship.

### **4. Winner Selection & Notification**

Winners will be determined by a random drawing, by a neutral party on or about June 30, 2018. Winners will be notified via email at the address on file with Lions Clubs International. If no email address is on file, notification will be made through the officers of the winner's Lions club. Winners in constitutional area 4 will receive notification through their club officers to comply with GDPR requirements. Entrants agree to publication and/or display of their names and likenesses to be made at the discretion of Lions Clubs International.

### **5. Waiver**

As a condition of entering this sweepstakes, entrant agrees that: (1) under no circumstances will entrant be permitted to obtain awards for any losses or damages, and participant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and waives any and all rights to have damages multiplied or otherwise increased; (2) any and all disputes, claims and causes of action arising out of or connected with this sweepstakes, or any prizes awarded, shall be resolved individually, without resort to any form of class action, and exclusively by arbitration; and (3) any and all claims, judgments and awards shall be limited to actual out-of-pocket cost associated with entering this sweepstakes, but in no event attorneys' fees.
